

Klemmer Scholarship Fund

<u>Scholarship Funding Amount:</u> Scholarships are awarded to those individuals showing less than a \$70,000 net income. The lifetime limit of scholarship award is \$1,500.00 per person for any adult or teen Klemmer ("Klemmer") class.

Scholarship Award Purpose and Goals:

The scholarship may cover full or partial tuition of any Klemmer leadership seminars, programs, webinars, presentations, keynotes, or other company based fee including any affiliate and/or associate program sponsored and endorsed by Klemmer including, but not limited to: Personal Mastery Seminar, Advanced Leadership Seminar, Heart of the Samurai Seminar, Samurai Camp, Youth Leadership Camp, and Quickening Seminar. Please note - Samurai Camp Coaching and the Playful Mastery Seminar are excluded from scholarship awards.

<u>Scholarship Committee:</u> The Scholarship Committee shall be comprised of the following members: Kimberly Zink, Krystal Zellmer, and Kristie Powers.

<u>Scholarship Promotions</u>: The Klemmer Scholarship Program will be advertised via multiple communications media, including the brand website, during various seminar and program presentations, and during affiliate presentations and programs in order to reach potential scholarship candidates.

<u>Candidate Criteria:</u> Scholarship awards shall be based on demonstrated need, willingness to apply leadership tools learned, and passion and dedication to personal growth and development, including a devotion to creating a world that works for everyone with no one left out. Scholarships will be awarded for tuition and fees, books or supplies or equipment required for an approved Klemmer program. Applicants must be approved to attend the Klemmer seminar for which the Scholarship Application is made. Scholarship awards will be paid directly to Klemmer for deposit in the name of the student name and recorded as paid in the amount of the Scholarship. The criteria by which all applicants will be evaluated will be objective and nondiscriminatory.

<u>Candidate Application Process:</u> Qualified candidates may complete and submit the application per the instructions on the application form. All completed applications must be submitted and approved **prior** to the event for which the Scholarship application is made.

- 5. Additionally, all applicants must submit 5 or more hours of community service to be turned in to Klemmer no later than 30 days after the class in which scholarship was awarded.
